The student/parents should submit an affidavit cum undertaking accordingly at the time of admission as per requirement.

Other Terms & Conditions

- Post Dated Cheques (PDCs) should be submitted for the Tuition fee, Hostel fee and Misc. Charges etc. for remaining 2 Years of the Course along with an Affidavit cum Undertaking notarized on a 100 Rupees Stamp paper duly signed by the candidate and parents/guardian. Student/parents are advised to transfer the payment through RTGS/NEFT (Cash) before the due date as per mentioned in their affidavit. Kindly update the payment transferred details to the given contact numbers. Delay in payment, the PDC will be deposited as per given date and If the cheque dishonored, penalty of Rs.25000/- will be imposed.
- Every subsequent year the student should get admission to the college and hostel by depositing the all fees in advance in the beginning of every academic year failing which late fee of Rs.1000/- per day will be charged as penalty on pending Fee.
- A sum of Rs. 25,000/ per subject should be deposited by the failed student in each supple exam of the study during every academic year
- Miscellaneous and other charges etc. should be deposited at the time of the admission and also beginning of each academic year.
- Students need to obtain permission and pay prescribed charges fixed by the Institute in advance for use of any Electrical Appliances such as AC, Fridge, Heaters, Induction, and Cooler etc.
- Charge for Using the Laundry Services of the Institute be paid separately.
- Charges for using Internet Services provided by the Institute be separately.
- Resident hostel students are not allowed to keep any type of vehicle inside the SIMS campus.
 They may however, in a very exceptional and rare situation, apply for the permission to the
 principals of their respective colleges. The decision of the Principals will be referred to the
 Management for final decision. Till such permission is received, no vehicles of hostel students
 will enter into the campus.
- As per College/University norms Enrollment and processing/professional charges of Rs. 75000/- (Rupees Seventy Five Thousand) one time charged.
- Tthe student should abide the rules and regulations of the Institute time to time.
- If the student tends to leave the course in between, then student have to pay all full fees for current, remaining years of the course and the security money will be forfeited.
- Student found indulged in any indiscipline activity or violation of rules and regulations of the institute, then the security money may be forfeited.
