Subject: Ch. Charan Singh University - Recognition of MD(General Medicine) qualification for 4 seats in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 10/10/2017 considered the Council Assessor's Report (5th September, 2017) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 4 seats at Saraswati Institute of Medical Sciences, Hapur granted by Ch. Charan Singh University and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (5th September, 2017) and decided to recommend to the Central Government that MD(General Medicine) qualification for 4 seats granted by Ch. Charan Singh University in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
